Due to these significant changes the Leptin Green Coffee 800, Leptin Slimming Green Tea, Leptin Cocoa and Pure Black products have been disclosed and comply with the Australia New Zealand Food Standards Code.

The formulation of the product will remain exactly the same. Any products, as of today, purchased from overseas will be considered a fake product and has **NO** guarantee under the Leptin Name for authenticity, effectiveness or safety – they can copy the packaging but they cannot copy the formula!!

The change of ownership has given the Leptin brand the business model it so desperately required to manage and continue its massive growth that the range has encountered in Australia in the last 12 months. Green Coffee 800 is Australia's No#1 selling "green coffee product".

How to know a counterfeit Leptin Product.

Unfortunately, with many products that have a rapid growth and successful sales, it opens the market to illegal or counterfeit product sales.
